- 3. To receive any declarations of interest in relation to any agenda item. No declarations of interest were declared.
- 4. Consider suspending the meeting to allow an opportunity for person(s) or groups to address the Council for a total of 15 minutes. There were no members of the public present so the meeting wasn't suspended.
- 5. Consider continuing the meeting. The meeting hadn't been suspended so continued.

12. Consider the changes being made to the planning consultation system.

Councillors noted the changes being made to the public consultation system and that this might mean more meetings being called to deal with these applications. It only will affect a small number of applications. The consultation period on Permission in Principle applications is short being subject to only a 14 day consultation period.

Permission in Principle can't be used for the following applications

- Applications to extend or alter a house
- Any "major" development that is more than 9 housing units or a development of a floor area of more than 1,000 sq m
- Any proposal that would have nature conservation impacts
- Any proposal that requires an Environmental Impact Assessment.

Councillors felt the new Permission in Principle consultation period shouldn't cause the Town Council a problem as meetings can be called quickly and a consultation response can be submitted within the timeframe.
