Meeting of the Town Council
Meeting Room Old Courthouse George Street Pocklington
Wednesday 11th November 2009 at 7.00 pm

Present: Councillor Sykes, (Chairman), Bryon, Cooper, Elliott, Marron, Held, Perry, Petrie, Scaife, Shepherd & Wilkinson.

Before the commencement of the meeting Tom Astell aged 13 years from the National Youth Parliament & Jayne Clarke from the Youth Service of the East Riding Council talked about the advantages of forming a youth council. This is considered a real investment to include and engage youngsters in the democratic process. What would be the advantage for the council? Provide feedback on issues, get a new perspective and lots of energy. Various models are available either a structured one where schools appoint members or a less formal arrangement. Objectives should be set early on. The ideal is for a small budget to be allocated so the youngsters can decide on priorities. Grants may be available from the Youth Opportunities Panel. The first meeting would see the officers appointed and a constitution agreed. It would be the intention to be as inclusive as possible with about 12 persons involved. A 'buddying' scheme might be suitable here where the young people regularly meet with chosen councillors. Consideration should be given to the members being drawn from all the years from year 6 onwards.

Rev Dalley the Council Chaplain then led the council in prayers.

The Mayor welcomed the new vicar, Reverend Geoffrey Hollingsworth.

3. Consider the Arts Centre Managers report

Both Janet Farmer the Manager and James Duffy the Assistant Manager attended to update the council on the latest figures from the Arts Centre. The newly released films were described. A school booking has been taken. Several sell out events have appeared. Gerry & the Pacemakers, Lionel Donegan are scheduled to appear shortly. The Bad Shepherds appeared recently and Elikie Brooks is coming in January. The Friends have organised a 'Swishing Soirée' next week to which everyone is invited. Both managers had judged the drama at Pocklington School. A particular success had been an exhibition of Steve Barnsley's work where 16 items had been sold. The accounts were outlined - traditionally low income quarter but better than budget. It will be possible to book on-line from December. For the 2010 anniversary year it is planned to have an open day and an event at Burnby Hall Gardens. It was hoped to have a Promenade of John Gresham's work throughout the whole building. Additionally a community singers event was being considered with Woldgate College.

4. Consider the formation of a Youth Council

The Mayor said he was supportive and asked for everyone's views. After a discussion it was decided to take all the steps possible to get such a council formed in Pocklington. It was agreed Marketing will be essential for the success of such a project.

Cllr Petrie proposed the minutes be accepted as a true record. 2nd Cllr Shepherd and agreed.

7. To consider the points brought up at the 2nd Annual Town meeting on 4th November
The main focus of the meeting seemed to be the problems being experienced with the 'zip-slide' on The Croft. A discussion took place about possible remedies whereupon it was decided to monitor all complaints for several months to gauge the problem. It was agreed to invite the dog warden to one of our meetings to explain what further can be done in relation to dog fouling. The speeding on Broadmanor was to be referred to Road Safety. The idea of having a celebration for St Georges Day was to be further explored with the French twinning group being invited?

8. Consider taking part in the energy saving initiative
Cllr Bryon outlined the challenge competition being organised by the Low Carbon Communities. We as a town have expressed an interest and must now register under phase 2. Twelve towns will be selected who will each receive £500,000. The projects we will put forward are 1. Energy use 2. Recycling 3. Sustainable transport. It was agreed to apply to be considered.

9. Update on the Mayor's Charity event 30th October 2009
Everyone agreed the event was a success and the Mayor reported proceeds of approaching £1,000. Special thanks were given to the singers who had obviously enjoyed the performance. It was agreed we would hold the 'Carols with the Mayor' event on Sunday 20th December at 2pm near the Christmas tree. Cllr Wilkinson will make 100 mince pies and Cllr Shepherd pledged £20 for tins of sweets to be given out to youngsters attending.
